Volkswagen Private Lease application - checklist

In order to process your application, we need to receive various documents in addition to your personal details. The checklist below will help you to collect the right documents.

Please note: The personal public service number ('burgerservicenummer') and the passport photo must be unrecognisable on all documents. Use the KopieID-application from the Rijksoverheid website (www.rijksoverheid.nl) for this.

Are you in paid employment? Then we need to receive the following documents:

- Copy of a valid driving licence.
- Copy of a bank statement (maximum 3 months old) showing the accommodation expenses.
The name, address and postcode details must be clearly visible, without any deletions.
- Copy of the fully visible front side of the bank card from which the private lease payments will be collected.
- Copy of salary statement (maximum 3 months old).
- The fully filled-in application form.

Do you have your own business? Then we need to receive the following documents:

- Copy of a valid driving licence.
- Copy of a bank statement (maximum 3 months old) showing the accommodation expenses.
The name, address and postcode details must be clearly visible, without any deletions.
- Copy of the fully visible front side of the bank card from which the private lease payments will be collected.
- If a one-person business/general partnership ('VOF')/partnership: Copy of an income tax return from the last financial year.
- If a private company ('BV'): Copy of annual accounts from the last financial year and salary statement (maximum 3 months old).
- The fully filled-in application form.

Are you retired or receiving a benefit? Then we need to receive the following documents:

- Copy of a valid driving licence.
- Copy of a bank statement (maximum 3 months old) showing the accommodation expenses.
The name, address and postcode details must be clearly visible, without any deletions.
- Copy of the fully visible front side of the bank card from which the private lease payments will be collected.
- Copy of a fully visible bank statement (maximum 3 months old) showing the benefit or pension.
The name, address and postcode details must be clearly visible, without any deletions.
- Copy of specification of pension/benefit.
- The fully filled-in application form.

Are there multiple contracting parties? Then we need to receive the following documents:

- Copy of a valid driving licence.
- If applicable: copy of a fully visible bank statement (maximum 3 months old) showing the accommodation expenses.
The name, address and postcode details must be clearly visible, without any deletions.
- If applicable: income on the basis of the abovementioned situations.
- The fully filled-in application form.

Are you divorced or married with a prenuptial agreement? Then we need to receive:

- A (signed) copy of the divorce agreement.
- A copy of the deed in which the prenuptial agreement is confirmed.
